It is designed for use in hazardous atmospheres including those identified as immediately dangerous to life or health (IDLH) – environments with little or no oxygen, with high concentrations of contaminants, or where concentrations of contaminants are unknown.

Combination Airline

As a Type C positive pressure respirator, the Ska-Pak 15-minute respirator can be used with various lengths of Scott supplied air hose for a combination of up to 12 segments, totaling 300 feet*. When used in conjunction with the 15-minute rated duration escape cylinder, users are provided with the mobility they need to connect and disconnect from remote air sources while safely moving from work station to work station.

*Up to 6 segments, totaling 150 feet when used with Hansen HK airline hose couplings.

Regulator

The benefits of the E-Z Flo® pressure demand regulator start with first breath activation. It is highly responsive to the users' breathing requirements and will provide peak flows of up to 500 standard liters of air per minute. Its low exhalation resistance means less effort to breathe and less fatigue. Doffing is made simple with the E-Z Flo's air-saver switch. Depressing the air-saver switch immediately stops the air flow into the mask.

Harness

The polypropylene harness is lightweight and comfortable with adjustable shoulder and waist belts to promote easy donning and doffing. The harness includes web adjusters and quick release buckles. A strain relief located on the waist belt prevents the regulator's air hose from tugging on the regulator during operation.

Cylinder

The fiberglass hoop-wrapped cylinder with aluminum inner shell has a working pressure of 3000 psig and has a rated duration of 15 minutes. The cylinder is hip-mounted and its retention system promotes quick and easy change-out once depleted.

Mask

The Ska-Pak 15-minute unit is approved for use with the AV-2000® or the Scott-O-Vista® full facepiece. Scott offers four color-coded sizes, including the Comfort Seal® face seal, to offer exceptional fit for the widest range of facial shapes and sizes.

Each mask features a hard-coated polycarbonate lens that provides a wide field of vision. Masks are offered with a choice of headstraps: easy donning mesh style harness available in polyester or Kevlar, and the 4-point rubber harness for quick cleaning and decontamination.
